This annual report is designed for consumers of drinking water within the Pine Forest Water System (PFWS), and provides information about the quality, source, and potential health effects of contaminants in our local and source water systems. This report conforms to the Federal regulation, contained within the Safe Drinking Water Act, which requires that this information be provided annually. This report contains a summary of the water quality test results from the PFWS source water and distribution system. The data contained in this report was collected during or prior to 2022.

DEFINITIONS

The following definitions may be used in this report:

MCLG – Maximum Contaminant Level Goal (The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.)

MCL – Maximum Contaminant Level (The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.)

AL – Action Level (The level of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.)

TT – Treatment Technique (A required process intended to reduce the level of a contaminant in drinking water.)

mg/L – milligrams per liter (This unit is equivalent to measurements in parts per million.)

ug/L – micrograms per liter (This unit is equivalent to measurements in parts per billion.)

pCi/L – picoCuries per liter (A measurement of radioactivity.)

SOURCE WATER

The source water for PFWS is supplied by four wells (S01, S02, S03 and S05) drilled 40-60 feet into an underground source of water, or aquifer. S01, S03, and S05 are collectively referred to as a well field (S04). S02 is located on Yellowleaf Road, while S04 is located below Blackjack Road. PFWS restricts any activity that could potentially contaminate this source. The waters pumped from these wells are blended together before delivery to your homes.

Source water tests are mandated by the Washington State Department of Health (DOH) to monitor the quality of the PFWS source water. This provides information on the quality of the water that is being pumped from the aguifer. Further information about the Pine Forest source water can be found in the source water assessment, on file with the Department of Health and Alpine Environmental. The assessment evaluates the potential risk of contamination that may be posed by activities or conditions in the area. SOURCE WATER TESTING SUMMARY

The following tests were performed on the PFWS source water in or prior to 2022. These samples were collected from a sampling tap at the pump house, and represent the water served from the source.

WHAT DOES "NO DETECT" MEAN?

Many of the contaminants listed in the results tables show an analytical result of "No Detect." This does not mean that the contaminant was not present in the water, but that the concentration, if any, was undetectable with the analytical methods used.

DELIVERED WATER

PFWS is required to test for contaminants throughout the distribution system. Samples are collected from at least three residences throughout the system to satisfy the DOH sampling recommendations and to best represent the conditions existing in the system. At least one water sample per month is analyzed for the presence of coliform bacteria. In 2022, coliform bacteria

were not detected in any of the 12 collected samples.

Lead and copper testing is typically required every three years, with samples collected from homes throughout the system after the water has stood in the pipes for at least six hours.

The table below summarizes the most recent lead and copper sampling results.

Some contaminants can have serious health implications if they are ingested in high quantities or over long periods of time. The table below provides information on those contaminants with potential health effects that were detected in your drinking water during or prior to 2022. While these contaminants were detected, they were at levels below the allowable limits set by the state, and therefore should not pose a health risk to most individuals. CROSS-CONNECTION CONTROL

A cross-connection is any connection between your potable water system and a non-potable water source, chemical, or other contamination source. In our use of drinking water, we create crossconnections every day, often without even realizing it.

Cross-connections are the single-most frequent sources of contamination for a water system, and it can be very costly to restore a system's integrity when contamination has occurred. Even more of a concern is the possibility that illness or even death could result from the consumption of water that has been contaminated through a crossconnection. For this reason, it is vital to ensure that cross-connections are eliminated or isolated whenever they are identified. Consumer education and the use of backflow preventer devices are the two most effective tools in reducing the hazards of cross-connections, and will be implemented as the need arises.

WATER USE EFFICIENCY

PFWS is committed to efficient use of water. Consumers are encouraged to quickly identify and repair of leaks to minimize water waste. Other actions that you can take include shutting off water if it isn't needed, installing low-flow fixtures, and restricting outdoor watering to nights and early mornings.

SANITARY SURVEY

Periodically, public water systems receive inspections to ensure that water is being delivered in a sanitary manner and that the system is being managed according to industry standards. A MESSAGE FROM THE EPA

Throughout Washington State, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. At the same time, this water can also pick up substances resulting from the presence of animals or from human activity.

All sources of drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency (EPA) Safe Drinking Water Hotline at 1-800-426-4791. Contaminants that may be present in source water, and that are routinely tested for, include:

<u>MICROBIAL CONTAMINANTS</u> such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

<u>INORGANIC CONTAMINANTS</u> such as salts and metals, which can be naturally-occurring or may result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

PESTICIDES AND HERBICIDES, which may come from a variety of sources such as agricultural and residential uses.

RADIOACTIVE CONTAMINANTS, which are naturally-occurring.

ORGANIC CHEMICAL CONTAMINANTS including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.

In order to ensure that our water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in the water provided by your water system. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide the same protection for public health. Washington State allows some contaminants to be monitored less than once per year because the concentration of these contaminants is not expected to vary significantly from year to year.

Additional Information

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. The EPA and the Center for Disease Control (CDC) provides guidelines on appropriate methods to lessen the risk of infection by Cryptosporidium and other microbial contaminants, and this information is available from the EPA Safe Drinking Water Hotline at 1-800-426-4791.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Pine Forest Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for thirty seconds to two minutes before using drinking water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Nitrate in drinking water at levels above 10 ppm is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue-baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask for advice from your health care provider.
