This annual report is designed for consumers of drinking water within the Vista Vue Water Users Association (VV), and provides information about the quality, source, and potential health effects of contaminants in our local and source water systems. This report conforms to the Federal regulation, contained within the Safe Drinking Water Act, which requires that this information be provided annually. This report contains a summary of the water quality test results from the VV source water and distribution system. The data contained in this report was collected during or prior to 2022.

#### **DEFINITIONS**

The following definitions may be used in this report:

**MCLG** – Maximum Contaminant Level Goal (The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.)

**MCL** – Maximum Contaminant Level (The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.)

AL – Action Level (The level of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.)

**TT** – Treatment Technique (A required process intended to reduce the level of a contaminant in drinking water.)

**mg/L** – milligrams per liter (This unit is equivalent to measurements in parts per million.)

**ug/L** – micrograms per liter (This unit is equivalent to measurements in parts per billion.)

**pCi/L** – picoCuries per liter (A measurement of radioactivity.)

## **SOURCE WATER**

The source water for VV is supplied by a well (S01) drilled 204 feet into an underground source of water, or aquifer. S01 is located on the left side of Omak River Road, on property owned by the association at the northeast corner of the Vista Vue development. VV restricts any activity that could potentially contaminate this source.

The water from S01 contains arsenic in levels above the established MCL of 10 ug/L. Typically, levels have averaged approximately 14-16 ug/L. In order to remove this contaminant, VV has been required to install an arsenic filtration system. Water percolates through two tanks containing an adsorption media that pulls the arsenic out of the water.

Source water tests are mandated by the Washington State Department of Health (DOH) to monitor the quality of the VV source water. This provides information on the quality of the water that is being pumped from the aquifer. Further information about the VV source water can be found in the source water assessment, on file with the Department of Health and Alpine Environmental. The assessment evaluates the potential

risk of contamination that may be posed by activities or conditions in the area. For a copy of this information, contact Alpine Environmental at the numbers listed at the end of this report.

## **DELIVERED WATER**

VV is required to test for contaminants throughout the distribution system. Samples are collected from at least three residences throughout the system to satisfy the DOH sampling recommendations and to best represent the conditions existing in the system. At

least one water sample per month is analyzed for the presence of coliform bacteria. In 2022, coliform bacteria were not detected in any of the samples collected from the system.

Lead and copper testing is required every three years, with samples collected from homes throughout the system after the water has stood in the pipes for at least six hours. The table below summarizes the most recent lead and copper sampling results.

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the cost of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other

health effects such as skin damage and circulatory problems.

The following tests were performed on the VV source water in or prior to 2021. These samples were collected from a sampling tap at the pump house, and represent the water served from the source.

# A MESSAGE FROM THE EPA

Throughout Washington State, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material. At the same time, this water can also pick up substances resulting from the presence of animals or from human activity.

All sources of drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.
